## Willits Lil' Stinkers RV Club

## Membership Agreement

## I - PURPOSE

Willits Lil' Stinkers RV Club brings together friends who share an interest in recreational vehicle (RV) travel and community service.

## II - MEMBERSHIP

1. A membership unit includes one couple or single and any dependent children.
2. Membership dues of $\$ 20$ per year per membership unit will be paid to the Treasurer by January 1 of the membership year. Dues for members joining during the fourth quarter of the year are deferred until the new year.
3. Members are encouraged to participate in club operation as officers, wagonmasters, or other service positions.
4. Membership candidates must attend two club events and be approved by all attending club members.
5. Members are encouraged to join the International Good Sam Club.

## III - MEETINGS

1. Meetings shall be held as voted by the members following informal meeting procedures.
2. Special meetings may be called by the Club President.
3. Club activities shall be publicized online at WillitsLilStinkers.org and in local media.

## IV - VOTING

1. Each individual member will have one vote in club business.
2. A quorum at any meeting shall by $50 \%+1$ of individual members.
3. All voting for new officers and members shall be by voice vote at alternating December meetings for the coming two calendar years.

## V - OFFICERS

1. The following Club officers shall be elected at an annual Club meeting, and will hold office for two years: President, Vice-President, Secretary, and Treasurer. Other duties may be assigned to members by the Club President.
2. The Club Executive Committee shall be comprised of all current officers and the most recent past-president.
3. Duties of Club officers shall be as follows:

President: Presides at all meetings; appoints all committees; supervises all Club activities; promotes club activities and membership.

Vice-President: Conducts meetings in the absence of the president; assists wagonmasters.

Secretary: Records the minutes of the meetings; receives, reads, and answers all correspondence after action taken by membership at meetings or at direction of Club president.

Treasurer: Retains custody of funds, securities, and assets of the Club; keeps full and accurate accounts of all receipts and disbursements; maintains membership roster with contact information; and regularly reports to membership.

## VI - CLUB TREASURY

1. All monies received by the Club from dues or any other sources shall go into the Treasury.
2. Any individual member may nominate worthwhile community service opportunities for donations and/or volunteer assistance by the club.
3. All expenditures of monies from the Club treasury shall be ratified by the membership at a regular business meeting.
4. All disbursements from the Club treasury shall be by check, signed by the Treasurer or designated alternate.
5. The President and Vice President shall annually audit the Club Treasury records.
6. The Club's treasury balance shall not be sustained below $\$ 250$ nor exceed $\$ 500$.

## VII - DISBANDMENT

If this Club shall decide to disband, all monies in the Club treasury shall be distributed as follows: Divided equally among all members in good standing after all outstanding debts are paid.

## VIII - AMENDMENTS

A proposed amendment of the Membership Agreement shall be presented to the President in writing and shall be read to the membership at two consecutive meetings before voting on additions or changes.
